

* El Camino Hospital is the legal and funding entity for El Camino Health's community benefit program. The community benefit requirement applies to 501(c)(3) tax-exempt hospitals.

Introduction & Overview of Community Benefit Grant Program

El Camino Health (ECH) and El Camino Healthcare District (ECHD) invest in the health of the community by committing resources to a variety of programs that benefit the community. Each entity provides separate grant opportunities for programs that align with current funding priorities and demonstrate the ability to meet the health needs of community members who are underserved, experiencing health disparities, and/or facing health challenges.

To which Community Benefit Grant Program should organizations apply?

The primary distinction between the El Camino Health and El Camino Healthcare District Community Benefit Program is geography. District funds are restricted to serve only those individuals who live, work or go to school in the District's boundaries*. The District funds both Program Grants and Support Grants (up to \$30,000 for agencies with an operating budget of less than \$1.5M). El Camino Health funds Program Grants only. Program Grant amounts vary depending on community need and program scope. **There are separate applications for each entity (ECH and ECHD). Please apply accordingly.**

✓ <u>El Camino Healthcare</u>

District: Grant programs serving individuals who live, work, or go to school in Los Altos, Los Altos Hills, Mountain View, Sunnyvale, **and/or** parts of Cupertino should **only** apply for El Camino Healthcare District funding. Programs need not serve every city in the District.

El Camino Health: El Camino Health's service area includes the El Camino Healthcare District's cities of Los Altos, Los Altos Hills, Mountain View and Sunnyvale as well as other parts of northern Santa Clara County, including Los Gatos, Saratoga, Campbell, San Jose, Cupertino and Santa Clara. Programs need not serve every city.

The following **five priority health needs** were identified in the 2022 Community Health Needs Assessment (CHNA):

Grant Program Eligibility Guidelines

In order for a potential grantee to be considered eligible for Community Benefit Program funding, the grant program must:

- Address identified health need(s) (see page 5)
- Meet geographic requirement by serving individuals who live, work or go to school in the District boundaries or El Camino Health service area (see page 3)

Applications meeting these requirements are evaluated based on the guiding principles outlined in the next section.

What does the Community Benefit Grant Program <u>not</u> fund?

- Contributions to individuals
- Political campaigns and legislative lobbying efforts
- Endowments
- Existing deficits
- Fund drives
- Medical research
- Research on drug therapies or devices
- Cultural events
- Projects that exclusively serve religious purposes

Grant Program Guiding Principles

Required:

- 1. Serve those who live, work or go to school in the targeted geography
- 2. Demonstrate a competence and capacity to address at least one of the identified health needs
- 3. Focus primarily, but not exclusively, on the results of increasing access to healthcare services, behavioral health services, as well as the management of rising risk chronic health conditions (diabetes, obesity, cardiovascular disease, cancer, and respiratory conditions)
- 4. Have an emphasis on populations that are underserved, experiencing health disparities, and/or facing health challenges

Preferred:

- 5. Aim to reflect the diversity of the targeted geography
- 6. Focus on operational programmatic costs for service delivery, over capital campaigns. Do not fund drives or political initiatives
- 7. Emphasize locally focused vs. national organizations
- Emphasize the most effective and impactful programs while welcoming new and innovative applicants

- 6. **Evaluation and Data Collection:** definition of a program service/encounter, plan to collect and assess data
- Program Metrics: Implementation Strategy Collective Impact Metrics, Volume & Impact Metrics (see pages 8 -9) on how to develop metrics and targets)
- 8. Required Documents*:
 - Cover letter: the cover letter must be signed by an individual with authority to enter into an agreement with El Camino Health or El Camino Healthcare District.
 - IRS determination letter: 501(c)(3) letter, if applicable
 - Audited financials: If you are unable to provide your most recent audited financials, you may submit your organization's most recent unaudited financials.
 - Executive Director and Board of Directors Roster on agency letterhead
- 9. Additional Information (optional): This is an optional section to provide any additional information.
- 10. **Application Survey (optional):** A link here that will open up a survey with 10 questions about our application process. Please take a few minutes to answer these questions and provide us with some feedback on our application process. All responses are anonymous. After or before completing the survey please do not forget to return to the application page and click submit to successfully complete the application process.

Metrics & Targets

Applicants must provide volume and impact metrics. Each metric has a midpoint and annual target; targets are projections that must align with **<u>only</u>** the funding amount requested in the application.

Overall Target Setting

- Use previous performance and data to inform target setting; returning applicants should review past metrics and outcomes to inform forecasting
- Metrics with <u>targets set at 100%</u> <u>should not be used</u>, as these suggest the metric is a program process rather than a stretch goal (i.e., clients receiving program materials)
- If awarded a grant, variance explanations will be required for outcomes that are above or below 10% of the target

Collective Impact Metric

In order to demonstrate collective impact, we are requiring our partners to align one of their metrics with the grant's associated health need category.

- Select <u>one</u> collective impact metric from your grant's health need category.
- Type the metric into the narrative box.
- Set midpoint and annual targets based on prior year performance or best approximation.

Volume Metrics

Volume metrics include 1) total individuals served (unduplicated) and 2) services provided (likely duplicated)

- 1. Individual served (unduplicated)
- The midpoint target need not be 50% of the annual target, consider the following:
 - Ramp-up time for a new program
 - Timeline for scheduled services
 - Time for outreach and referral efforts to achieve desired outcomes
- Each individual should only be counted <u>one</u> time, even if the individual receives more than one service or encounter.
- Volume metric targets must be set as raw numbers.
- 2. Services provided (likely duplicated)
- Services provide information on the volume of interactions with individuals served. The services should be larger than the number of unique individuals served.
- Volume metric targets must be set as raw numbers.

Impact Metrics

Impact metrics are quality measures that demonstrate the impact of funded services.

- When measuring increases, decreases, or improvements, it is recommended that a <u>qualifier*</u> be used in the metric narrative that describes the change (see * in "Improved Sample Impact Metrics" on the next page).
- <u>Targets for impact metrics must be set as percentages</u>, <u>not raw numbers</u>
- Impact metric language should be informed by your program evaluation tools (e.g., survey, scale, etc.)
- Please see examples on the next page.

Funding Request Guidelines • The Community Benefit Grant Program is

- The Community Benefit Grant Program is an important strategy for addressing longterm community health challenges.
- Incremental increases are more feasible than large variations from one year to the next.
- It is important to articulate clearly the role that El Camino Health or El Camino Healthcare District funding would play in relation to other funding sources for new or existing programs.

Application Submission, Review and Notification

- Upon application submission, you will receive a confirmation e-mail within one to three business days. If you do not receive a confirmation e-mail, please contact (650) 940-7052 and leave a message for Community Benefit.
- El Camino Health proposals are reviewed by the Hospital Community Benefit Committee and approved by the Hospital Finance Committee; El Camino Healthcare District proposals are reviewed by the Community Benefit Advisory Council and approved by the El Camino Healthcare District Board of Directors. Follow-up questions or requests for additional information may arise during the review process; please ensure accurate contact information is provided in the application.
- The El Camino Health Finance Committee and El Camino Healthcare District Board of Directors are the final decision making bodies for Community Benefit funding.
- Notifications of awards and denials will be sent via e-mail in late June 2022, followed by a formal grant agreement.
